Tribute to Bob Kozura By Eileen Law Stewart

When we received word of Bob Kozura's passing, for many of us, the stab in the heart we felt & the confusion trying to wrap our heads around this devastating news, for some of us, well, it could be likened to that unforgettable day known as "9/11." It was utter shock & profound sadness. What's worse, we didn't learn of his passing on May 12th until much later, after the services had already been held. We didn't get to say good-bye to our dear friend & colleague, so we're taking this opportunity to remember and honor him now.

Bob was just 67 years old when he was taken from his beloved wife, Kathy, & their children, Kris and Jennifer, his grandchildren, mother, & siblings, & all of us! While he was born in Pottsville, he made his home in West Brandywine Township, Chester County.

He met his wife, Kathy, while working as a security manager at K-Mart. They dated for a while, & he knew sooner than later he wanted to make her his wife. However, they would not allow husbands & wives to work at the same store, so Bob started looking for another job.

He became a claims adjuster for a trucking company. That was "o.k." but he knew he wanted something more challenging. While looking through the newspaper one day, he saw an ad for an investigator in the Philadelphia area. He thought that would be interesting. He applied, & got the job & loved interviewing people & traveling, but found the surveillance end of it boring. After working for this company for a few years, he decided to branch out, petition the court for a private detective's license & start his own business.

He opened SPI ~ Southeastern Pennsylvania Investigations ~ from the basement of their home. His family used to tease him when he would walk to the stairs ready to go downstairs to begin work & they would say to him, "We hope your commute to work isn't too bad!" They would all have a laugh.

Bob loved his family & was a great handyman. He was a sports-a-holic & especially loved the Union Soccer Team. He also enjoyed camping. Kathy told me that she had a knack to overcook everything she made for dinner. While Bob wouldn't complain, when she would buy a nice steak or something special for dinner, Bob would insist they he take over & would tell her, "I'll be cooking tonight!" He & Kathy shared 43 years of marriage together.

When Bob joined PALI, he jumped right in & became somewhat of a "go-to" person, always helping people & researching information before he gave his opinion. He was on just about every committee we had, helped plan conferences, write By-laws, was an advocate for changing the Private Detective's Act of 1953, & so many other matters. He was at almost every conference, extending his hand to everyone. We never saw him get angry, & he had a calming way & a knowing smile. You could almost see the wheels in his head spinning before he gave an answer. (I only wish he had passed along that trait to some of us! Myself included.) He was the best listener one could ask for & had a memory like a steel trap.

He was on the board of directors as second vice president for many years – having no desire to "move up" just to stay right where he was & jump in when needed. He was chairman of several conferences, & hosted many "free lunches" to bring potential members in & headed up the "Jim Carino Investigator of the Year" Award. If you looked up the word "Integrity" in the dictionary, I'm betting Bob's name would likely be there.

There was an occasion, however, that he was conducting an investigation on a subject & had him under surveillance for several days, one day a police officer knocked on his door & told him to stop his investigation & cease his surveillance on the subject. Unlike what MANY of us might have said to that officer & not one to be intimidated, Bob replied, "O.k., Officer. I'll do that. But I have no way of contacting my associate who is also on this case, so be aware of that. It's out of my hands." The disgruntled officer left. The thing is: Bob HAD no "associate!" THAT was just Bob's way!

I have every confidence that when Bob took his last breath here on earth, he was greeted in Heaven by the words: "Well done, my good & faithful servant."

PALI has raised the bar where organizations in the investigative industry are concerned, and it's due in large part to the input by members just like Bob.

In all of the years PALI has been in existence, we have given just two "Lifetime Achievement Awards" to members who raised that bar & made a difference. Those people were Barry Ryan and Jeff Fry.

When I made the motion to the board to consider presenting yet another recipient for that coveted award, it was met with immediate agreement & a resounding, "Yes!" Therefore, we are proud & honored to present The Lifetime Achievement Award, posthumously, to Bob's Wife, Kathy Kozura.

2023 PALI INVESTIGATOR OF THE YEAR ACT 1: FRANK V. DeANDREA, Jr.

PALI NOMINATING MEMBER: MULTIPLE MEMBERS PRESENTED BY: EILEEN LAW STEWART

Over the past 4 decades, the recipient of this award has dedicated himself to the betterment of investigations, the community and our country. If I were to read all of his accomplishments, we'd be here all night.

He enlisted in the US Army right out of High School & was in the Military Police Corp. While serving at Fort Dix and out for an evening run, he spotted smoke coming from the window of a housing unit and without hesitation, made three trips into the house to get the family of five out of the fire, physically carrying the father who was overcome by smoke as well as finding a child on the 2nd floor.

He scored 3 out of 16,000 applicants and was accepted into the Pennsylvania State Police Academy later becoming a Forensic Expert.

He was part of the DUI task force, & during one of his shifts, a drunk driver led state police on a 3 hour pursuit through 2 counties, ramming several Patrol Vehicles & injuring 12 State Troopers including himself, when his left hand & wrist were pinned under a smashed vehicle. Ignoring his injuries, he carried a State Trooper who was bleeding from his injuries to safety carrying the Trooper on his back. He then led the search & assisted in the apprehension of the suspect. Only after all of his men were transported to the Hospital & the violator apprehended, did he go to the hospital where he would later have surgery on his wrist.

On September 11, 2001, he volunteered to go to the Flight 93 crash site & set up the communications using the Pennsylvania State Police Mobile Computer system that he designed, giving them cellular access which allowed for over 100,000 license plates to be run & checked by Police who manned the perimeter of the crash site.

In 2011, he was given 6 months to live with a diagnosis of throat cancer, which had spread throughout his lymphatic system. This ended his career abruptly but, certainly not his life.

He was formerly Chief of Police of the City of Hazleton implementing many procedures & creating numerous programs.

Four years later, he co-founded his detective agency. He has spoken on Capitol Hill on areas of Police reform, he is a renown international speaker, newsletter editor and police academy instructor.

When he became a member of PALI, he didn't hesitate to volunteer for a myriad of committees, helping his fellow members both personally & professionally. He never said, "no" when asked to do any task. Four years ago, he was asked to resurrect the PALI Newsletter, & graciously accepted the responsibility. It's now a virtual book!

He is a loving & devoted husband & the father of six children who, collectively, are his reason for doing what he does. Many of us are proud to call him not just colleague, but "friend."

2023 PALI INVESTIGATOR OF THE YEAR ACT 2: SANDY DeANDREA

PALI NOMINATING MEMBER: MULTIPLE MEMBERS PRESENTED BY: EILEEN LAW STEWART

She handles background & financial investigations, as well as providing services in missing person investigations. She has volunteered to assist the underprivileged by often providing gratis investigative assistance to individuals & families who are in need.

With over 27 years as a Pennsylvania State Police Trooper & Corporal, she rose through the ranks to become a Financial Crimes Top Gun Instructor, uncovering & stopping several plots of domestic terrorism & hate crimes. Working deep undercover, she maintained a covert identity and infiltrated the highest level of two international organized crime rings.

When there was a need to fill the first vice president position when a PALI board member had to vacate that position, Sandy didn't hesitate to accept that position & is an active member of the board.

She is a nationally renowned speaker & considered an expert on Financial Fraud, Asset Forfeiture, Surveillance and Undercover Investigations.

Two years ago, Sandy solved a fatal hit & run homicide in her hometown after the police investigation went cold. The family reached out to her & she took on the case Pro-Bono insuring that the death of their 15-year-old did not go unsolved. In 2 days, Sandy located the suspect, receiving a full confession from him, then drove him to City Hall where he turned himself in and confess to the police.

She instructs police academy cadets on all aspects of Law Enforcement, & is a certified Police Academy Emergency Vehicle Operation instructor and a Defensive Tactics instructor, maintaining her black belt in karate.

Sandy is the mother of six children & runs a kitten rescue where she'll capture, nurture to health & then have spay or neutered feral kittens. She is responsible for identifying the need for a Trap, Neuter & Release program for stray animals & also designed an animal clinic to be built in her community, funded by a Trust that she had been part of.

After multiple nominations were received individually for both Sandy & Frank, I recommended to the committee to consider having a "Joint" award. Initially, some were concerned, believing that it may detract from the honor of the award. We're confident that neither of them would complain, as they are joined at the hip. The bottom line is, each of them make the world a better place in which to live and they are the epitome of the saying: "THE WHOLE IS TRULY GREATER THAN THE SUM OF THE PARTS!"

Therefore, we are pleased to present the other "2023 Investigator of the Year" award to **Mrs. Sandy DeAndrea.**





LEGISLATIVE & LEGAL CONCERNS

PENNSYLVANIA CRIMES CODE TITLE 18 CHAPTER 41 - FORGERY AND FRAUDULENT PRACTICES SECTION 4115 - FALSELY IMPERSONATING PERSONS PRIVATELY EMPLOYED

§ 4115. FALSELY IMPERSONATING PERSONS PRIVATELY EMPLOYED.
A PERSON COMMITS A MISDEMEANOR OF THE SECOND DEGREE IF, WITHOUT DUE
AUTHORITY, HE PRETENDS OR HOLDS HIMSELF OUT TO ANY ONE AS AN EMPLOYEE OF ANY
PERSON FOR THE PURPOSE OF GAINING ACCESS TO ANY PREMISES.

Private Investigators should be aware of this section of the Pennsylvania Crimes Code and consult with the District Attorney of their county for guidance as to their DA's interpretation of how this affects a PI dressing in any type of uniform or outfit to serve papers to a person at their home or business.

Much discussion can be made pertaining to the interpretation of "due authority", and "an employee of any person".

This article is NOT to take sides or discuss the issue, it is simply to make all Private Investigators aware that section 4115 exists and may be interpreted by District Attorney Offices as meaning a Private Investigator cannot dress in a Pizza Delivery, Amazon, Fed Ex, Municipal Authority, or the likes uniform in order to gain access to a premises to serve papers, conduct surveillance etc.

This is a cautionary article to inform Private Investigators and have them seek legal counsel in their own jurisdictions from their own District Attorney's Office as to how this law will be interpreted.





LEGISLATIVE & LEGAL CONCERNS

During the 2023 PALI / NJLPIA Joint Conference Jennifer Sirois, NJ, PA, DE Licensed Private Investigator briefly spoke pertaining to an upcoming dinner meeting where the topic will be: **Know Your Customer**; It Could Be a Foreign Intelligence Entity

In a follow up e-mail sent by Jennifer Sirois through the PALI listserv she explains
The topic of education is: Know Your Customer; It Could Be a Foreign Intelligence Entity
Presented by the FBI Field Office, Newark NJ and NJLPIA Board Member, Jennifer Sirois.

Presentation

FBI Supervisory Intelligence Analyst Michael Pohl will provide a threat overview regarding the increasingly common efforts of hostile foreign intelligence services, including those belonging to the Peoples Republic of China and Iran, to target and try to co-opt US private investigators into conducting investigative work in furtherance of foreign intelligence operations. These operations can include further a variety of malicious goals, but most commonly involve investigating vulnerable US-based dissidents, sometimes with the end goal of forcibly repatriating the subject back to the country from which they fled. This is called Transnational Repression, and is a tactic used by authoritarian regimes to control the activities and speech of diaspora communities overseas. Mr. Pohl and Mr. Martin will share facts from actual cases and will provide tools that PIs can use to identify and report suspicious customers that may actually be foreign intelligence officers.

Private Investigator Jennifer Sirois, LTC Army Retired, and NJLPIA Executive Board Member will brief federal statues that a former NJ private detective was convicted of violating in furtherance of foreign intelligence operations. She will also review the NJ & PA Private Detective Acts and associated privacy laws. The purpose of this overview is to inform members what actions and activities are granted to an individual who holds a private detective license and what actions and activities fall outside the scope of law.

As a follow up to President Carpenter's email, Jim Carino penned this about Bob's repose: *PALI Members*.



SOU-DOZ

SECRET RECIPE HOMEMADE BREAD

Recipe By: Frank DeAndrea, Sr.



FRANK DEANDREA, SR.'S HOMEMADE BREAD MAKES 2 LOAFS

INGREDIENTS

3 ½ CUPS WARM WATER (105-115 DEGREES)
3 PACKS ACTIVE DRY YEAST (USE FRESH YEAST)
3 TABLESPOONS SUGAR
8 CUPS FLOUR
2/3 CUP EXTRA VIRGIN OLIVE OIL

- Proof the yeast: In a large bowl add yeast, water and sugar. Allow to rest in a warm dark place for 5-10 minutes until foaming and bubbly. (If it doesn't foam, the yeast is no good, and you need to start over with fresh yeast).
- 2. Prepare the dough: Add 2 Cups of flour and mix. Add the 2/3 cup of Olive Oil. Mix. Add flour 1 cup at a time, mixing until it has formed a ball and can be turned out onto the counter.
- Keep mixing flour until it is no longer sticky. Sometimes it will take the entire 8 cups, other times it will not.
- 4. Knead the dough: Mix the dough for 5 minutes with your hands on a lightly floured surface. The dough should be smooth and elastic but not be overly sticky.
- 5. First Rise: Grease a large bowl with shortening and place the dough inside. Cover with a dish towel or plastic wrap and allow to rise in warm place until doubled in size (about 1 hour).
- 6. Punch the dough down several times to remove air bubbles.
- 7. Divide into two equal portions. Shape each ball into long logs and place into greased loaf pans.
- 8. Second rise: Spray two pieces of plastic wrap with cooking spray and lay them gently over the pans.

 Allow dough to rise again for about 45 minutes to one hour, or until just above the loaf pans.
- Bake: Adjust oven racks to the lower middle position. Preheat the oven to 350 F. Bake both loaves of bread for about 35-40 minutes, or until golden brown on top.
- 10. Invert the baked loaves onto a wire cooling rack to remove from pan. Tap the bottom. They should sound hollow when done. Turn over and brush the tops with butter and allow to cool for at least 15 minutes before slicing.
