

### WELCOME FRANK V. DeANDREA, Jr. Editor-In-Chief

The Massacrist's defense team moved to suppress all evidence of the DNA findings stating they were obtained by the FBI breaking a policy of the database company. Although to many, it seems DNA has always been around as a means of identification, DNA was not always allowed to be used in court. The ability to use DNA in the Pennsylvania court system dates to 1993, Commonwealth vs James Lee Lindsay. This was the test case to allow DNA to be used as evidence to positively identify a person.

In 1993 Lindsay was arrested and charged with being a serial rapist at Bloomsburg University, raping seven college women and burglarizing their homes. In a trial by jury he was found guilty and given a sentence of 22 to 44 years in prison for his confession and conviction. During the time he has been in prison, he has filed no less than eight appeals having the case go through the Supreme Court upholding the acceptable use of DNA in court to prove identity.

I know this as in 1992-1993 I was the State Police Trooper who processed the crime scenes and collected the evidence convicting him. Equally, I was the State Trooper who captured Lindsay as he attempted to flee through an alleyway after committing another burglary and attempted rape.

Technology has evolved at breakneck speeds since then. Often policies, procedures and laws lag behind usually waiting for an issue to arise prior to being created or updated.

The case of drones is equally a compelling example of this. As drone use and technology expands, we are faced with the lack of laws governing use, identification and control.

I am confident that laws will catch up quickly to govern the responsible use of all technology. However, in this gray area of time between technology evolution and the laws that will govern it, we as investigators should allow our conscience to guide us and at all times, remain ethical as we spring ahead! Remember it might just be your involvement in a case that will one day be reviewed by the Supreme Court.

### RAISING THE DEAD

At times, my work proves to be quite engaging. Recently, I was tasked with finding a client for one of my attorney clients. Through thorough research, I was able to uncover extensive information about this individual, including details about his family members such as his ex-wife, children, brothers, and sisters; however, I was unable to locate the individual himself.

I discovered that his sister passed away in April, and he was mentioned in her obituary as having died before her. Conversations with his family revealed their belief that he perished in a house fire in the Kensington area of Philadelphia, with the body being unidentifiable. They presumed it was him but never received the remains. Consequently, there was no burial or memorial service, which deeply saddened me.

I conversed with his son, who revealed that he had not seen his father for two decades. This prompted me to further investigate, as I was determined to pursue the matter despite their assertions. I sensed that their information was inaccurate and felt a compelling need to uncover the truth.

I contacted the City's Medical Examiner's Investigative Unit, but they reported no record of the individual and no unidentified remains of a burn victim. As is my habit, I became fixated on this issue, mentally pacing for hours until a new idea emerged. I considered that there might be alternative approaches, and indeed there were; this prompted me to explore a potential old or current address. The updated location was identified as a soup kitchen in Kensington, Philadelphia, known as "The Saint Francis Inn." This Catholic organization serves the homeless population in that area of the city. I resolved to pay them a visit the next morning.

Upon my arrival at the Saint Francis Inn, I observed numerous homeless individuals resting on the sidewalk adjacent to the facility. The scene was not limited to just a few; rather, it was populated by many. The morning was brisk and chilly, the type of day where one's breath is visible in the air, and litter and debris were scattered in every direction. After parking my vehicle, I stepped out, dressed in a suit that day, presenting a polished appearance.

At 8:00 AM, I rapped on the side door. A gracious nun welcomed me inside the inn, inviting me off the street. I introduced myself and outlined my purpose for visiting. Inquiring if she was familiar with the individual I was seeking, I noted that I was dressed in a suit, as I had a funeral to attend at 10:00 AM.

Sister informed me that she was familiar with the individual I was searching for, although she had not encountered him recently. She mentioned that his mail is delivered to their address, which serves as his mailing location. She verified that he is currently homeless. According to her, he occasionally visits the Inn to collect his mail and enjoy a meal. I provided Sister with my

business card and requested that she ask him to contact me if she happens to see him.

I proceeded to a different location on North Broad Street, where I found a closed church. After circling to the rear of the church, I discovered it housed a breakfast mission. I entered to ask about the man associated with this site, but regrettably, he was not listed in their records. Consequently, I returned to my vehicle and left for Warrington, PA, to pay my respects to my friend following the passing of his mother, whom I had never met.

While driving home from the funeral on the Pennsylvania Turnpike, I received a call from the Saint Francis Inn, as indicated by the caller ID. It was Sister from the mission, whom I had met earlier that day. She informed me that someone had come in to collect his mail—he was alive. She then connected us, and I explained my attempts to reach him, sharing all the necessary details and requesting a meeting at the mission in about an hour. He agreed, mentioning that he had no phone or permanent address and would wait for my arrival. When I met him, it was clear he was very much alive.

Upon our meeting, he appeared to be in good health and high spirits. We conducted our business and engaged in conversation. He was unaware of his sister's passing, which left him astonished when I mentioned my communication with his ex-wife and son. My responsibilities were fulfilled. However, about an hour later, his ex-wife reached out to express her gratitude, as he had contacted her. Subsequently, his son called, utterly bewildered and unable to comprehend that his father was still alive. Both were completely taken aback by the situation.

God has placed me in this role for a purpose, a belief I hold firmly. At times, I feel a compelling urge that transforms into an obsession, as if I am aware of His presence, yet blinded to it. I am continually grateful for the gift and passion I possess for my profession. It transcends mere financial gain; it is fundamentally about revitalizing lives by raising the dead.

## RISK THREAT & VULNERABILITY ASSESSMENTS

To Check or Not To Check-That is the Question The Use of Checklists in Risk/Threat/Vulnerability Assessments

The purpose of a risk, threat and vulnerability (RTV) assessment is to help identify, prevent, reduce, or mitigate the potential consequences of a domestic terrorist attack, natural catastrophe, other emergency or safety / security problem that can adversely affect the company, its employees, the customers or the community.

This can be a large scale RTV assessment conducted on a major building, structure or critical infrastructure such as a professional football stadium, national or state monument, bridge, or water treatment facility, using all-hazards scenarios to identify critical community asset risks and their potential impacts to a community.

Equally as important are the smaller RTV assessments that are done on small businesses such as drug stores, convenience stores, grocery stores, hardware stores, ice cream parlors, coffee shops, the list is endless. In cases such as the smaller "mom and pop" shops, the focus is not as much domestic terrorism as it is protecting the business, employees, customers and community from dangers such as slip and falls, parking lot crime, injuries, accidents and the like.

#### FEDERAL EMERGENCY MANAGEMENT AGENCY NEW STANDARDS

As of 2024 the Federal Emergency Management Agency (FEMA) has created new standards of risk management that now take into account information technology.

A collaboration of physical and cybersecurity in developing an integrated risk management strategy leads to the enhanced capabilities necessary for the protection of our Nation's critical infrastructure as well as organizations, businesses and communities.

FEMA now considers Enterprise Risk Management critical regarding the protection of our infrastructure. The overall goal is to have physical security and cybersecurity working together through convergence and should be incorporated into any RTV assessment.

#### **USE OF CHECKLISTS**

In conducting an RTV assessment, the use of a check list can be a great tool. They are a much-used tool in many facets of assessments; however, I am here to tell you the checklist, left unchecked, can be dangerous.

There are advantages and disadvantages to the use of checklists and recognizing each is the key to success.






#### **RISK THREAT AND VULNERABILITY ASSESSMENT METHODS**

There are several ways to identify RTV's. Several of the schools on RTV assessments utilize interviews, discussions, and even scenario analysis. Others teach a more disciplined approach utilizing risk categories and checklists based on experience. Finally, there are software-based analytical methods that calculate permutations and identify risks based on a database using a multitude of data and even artificial intelligence.

#### **CHECKLIST CATEGORIES**

- The categories within an RTV checklist can vary from organization to organization and should be tailored to the specific entity assessed.

#### **CHECKLIST ADVANTAGES**

Some of the advantages of using RTV checklists:

- They are a very popular tool in many organizations.
- A properly prepared checklist can identify some potential risks, threats and vulnerabilities that can hamper, hinder and even render an organization helpless.
- Checklists give you a quick overview.
- Checklists have the advantage that you can use them to perform a risk analysis relatively quickly and easily.
- Checklists can be based on the vast experience of the professional who is conducting the RTV assessment.

#### **CHECKLIST DISADVANTAGES**

Some of the disadvantages of using RTV checklists are usually very specific and static. These lists are most often based on experience, past experience and even past failures based on problems that have occurred to other organizations in similar disciplines. Often the checklists are based on typical issues that may arise.

- Checklists give a false sense of security that ALL risks have been identified.
- Checklists do not allow for out of the "Checklist box" thinking.
- Checklists are static and only ask for a box to be checked.
- Checklists include only known and obvious risks.
- Checklists are not based on things uncovered from interviews.
- They do not provide a great amount or any detail.
- The list may be too ridged.
- The checklist does not qualify or quantify the risk.

#### OTHER THINGS TO CONSIDER

"Back in the Day" you were called upon to conduct a risk assessment and you pulled out your sturdy clipboard and checklist and started checking off the blocks. That day has long passed and there is so much more to consider in today's world to keep business, organizations or critical infrastructure safe. Let's look at some of the other things that are paramount to an RTV assessment being successful.

#### TRAINING and CERTIFICATIONS FOR RTV ASSESSMENTS

To conduct a professional RTV Assessment, the first thing any professional should do is get educated. There is a lot to be said for experience in the industry however, in today's rapidly evolving world, formal education through taking RTV Assessment courses is critical to remain on the cutting edge of the industry. Speaking from over 40 years of industry experience, I can tell you firsthand that without continuing education, I would not be able to properly assess risk in today's world.

#### **DIFFERENT SCHOOLS OF THOUGHT**

There are several schools of thought when it comes to conducting RTV assessments and each has their merits and a slightly different approach to them.

Some of these are:



**SWOT analysis -** Assesses an organization's strengths, weaknesses, opportunities, and threats.

**Risk matrix -** Multiplies the likelihood of an event by its severity to determine a risk score.

**FAIR -** Converts risk into financial terms to help organizations understand the potential economic impact of cyber threats.

**CARVER** - CARVER is an acronym that stands for Criticality, Accessibility, Recuperability, Vulnerability, Effect and Recognizability.

**FEMA CRITICAL INFRASTRUCTURE SECURITY** – FEMA has a multitude of courses specific to Critical Infrastructure Security.

Each of these approaches utilizes things such as heatmaps, graphs, charts, matrices, and formulas as part of the assessment process.

#### **FORMULAS**

Formulas are generally standard being the same calculation in all disciplines. Some examples are:

Formulas for calculations such as the risk formula generally written as

Risk = Probability x Impact.

Cybersecurity: Risk = Probability of Threat Event x Vulnerability x Impact

Software security: Risk = Likelihood x Impact

Risk = Threat x Vulnerability: A common formula used to identify and prioritize risks.

Risk + Response = Vulnerability

Risk = Probability x Impact

Likelihood x Impact = Risk Rating

System Effectiveness (SE) = Probability of Detection (Pd) x Probability of Interruption (Pn) SE=Pd×Pn

FEMA looks at five steps of Risk Management Framework are:

- 1.Set goals and objectives
- 2.Identify infrastructure
- 3. Assess and analyze risks
- 4.Implement risk management activities
- 5. Measure effectiveness

Formulas are usually based on the matrix being created.

**5x5 Risk Matrix** - A 5×5 risk matrix is a type of risk matrix that is visually represented as a table or a grid. It has 5 categories each for probability (along the X axis) and impact (along the Y axis), all following a scale of low to high.

#### DEPARTMENT OF HOMELAND SECURITY RISK MANAGEMENT LEXICON

Risk management strategies are essential for preventing, reducing, or transferring the impact of risks. They are fundamental to maintaining operational continuity and ensuring the resilience of organizations and systems. The risk management strategies include:

2.AVOIdance

2.Mitigation

3.Transfer4.Acceptance

#### **QUANTITATIVE vs QUALITATIVE ANALYSIS**

A quantitative risk assessment translates potential risks into numerical values. These are then used to measure the chance of occurrence and the amount of impact they will have on the organization. This employs statistical models, mathematical calculations, and financial metrics to estimate the probability and potential financial loss associated with each risk.

A qualitative risk assessment uses risks identified by the assessor, either by experience or interviews, and evaluating them based on their likelihood of occurrence and severity should they occur. Qualitative assessments are said to be subjective.

#### **OUTSIDE IN vs INSIDE OUT**

Outside in is the perspective of a criminal or intruder having to get to your business or asset from the outside and work their way in.

Inside out is the perspective of the people on the inside such as security professionals and employees.

A good RTV assessment will incorporate both approaches. If you only do one or the other, you may find gaping holes were not identified and failure is imminent.

#### **TOOLS TO CONDUCT A RTV ASSESSMENT**

Regardless of what RTV religion you practice, there are some tools that will be useful in each case. Items such as a:

**CAMERA** – A good digital camera is a great investment. Although cell phone cameras are incredible tools, the possibility exists of having the contents of the phone subpoenaed in discovery and as such, using a separate work camera only used to take work photos is a good investment.

**LIGHT METER** - This will allow you to properly gauge the lumens in all areas of the parking lot and interior of the building. Some models allow for the data to be written to an SD card and downloaded making population of a report easy.

**FLASHLIGHT** – There is always at least one area that needs to be lighted to see.


**CLIP BOARD** – This will allow important paperwork to be readily available as well as for checklists to be used when appropriate.

**TAPE MEASURE –** 100 foot and 25 foot retractable

**AUDIO RECORDER** – Used for quick note taking and interviews.

NOTE- NEVER RECORD ANYONE WITHOUT THEIR EXPRESSED PERMISSION AND ALWAYS ADD A SHORT PREAMBLE TO THE START OF THE RECORDED INTERVIEW SIMILAR TO:

This is (STATE YOUR NAME AND COMPANY) and it is currently (TIME AND DATE). I am conducting an interview with (STATE THE PERSONS' NAME) and they have granted permission to record the conversation. Mr. / Mrs. / Ms. (STATE THEIR NAME) please state and spell your name for the recording and that I have permission to record you.



LAWS pertaining to recording should be verified with an attorney within the state the recording is going to take place in. There is no reason while conducting a RTV assessment to perform any covert recordings.

#### **BENEFITS of a HYBRID APPROACH**

Using any specific method, be it FEMA, CARVER, CHAMELEON, 5x5 matrix, ASIS or the like, should show you that there are multiple approaches, each having several steps and utilizing several tools. Although the use of a checklist can be quite valuable, they should be used as one arrow in the quiver of a warrior and not as a singular method of assessment.

Once all of the interviews and policy review are completed, a checklist can be developed to ensure nothing was missed and that all potential threats identified in interviews and research have been assessed.

#### CONCLUSION

After reading this article, I hope it becomes apparent that the risk assessment world is rapidly changing and staying on top of it means constant updates in education as well as practical application. Checklists are a great tool and although they can be used as part of an RTV assessment they should never be the entire assessment.

# THANK YOU An Interpretation of Lord Kelvin's Second Law of Thermodynamics - THE ARROW OF TIME By: FRANK V. DeANDREA, Jr.



I buried my mother last month, February 2025. She was an amazing woman in so many ways. Always the epitome of a lady with never a bad word to say, she was one of the greatest teachers I know. Not in the sense of being a schoolteacher, she was a life lesson teacher.

My mother had a debilitating muscle disease that made simple tasks such as standing, walking and even swallowing incredibly difficult. Yet, even on her worst day, whenever anyone walked into the room, she would light up and welcome them as if they were the most important person in the world. She loved adventure and remained a child at heart. She was the epitome of patient, always kind and gentle. She was perhaps the most considerate person I will ever know. Incredibly giving, always thankful and lived up to her middle name, Grace, perfectly. In her death she taught me perhaps the greatest lesson of all, although be it bittersweet indeed. Clearly her death was the greatest example of the second law of thermodynamics one can ever witness.

In the fist law, also lovingly referred to as the Conservation of Energy law, it would allow for a cup to fall off a table, strike the floor and shatter into a thousand pieces as well as allow for the reverse process of the same fragmented cup to come back together as it is jumping back onto the table.

The second law, however, denies the latter. The second law, which used to be my favorite, is formulated by the observation that the total entropy (measure of disorder or randomness in a system) of an isolated system will always increase over time. Simply stated, in any natural process, the disorder or randomness of a system and its surroundings will always increase, never decrease.

It is the irreversibility of natural process, often referred to as The Arrow of Time.

My mother, in her passing, has instilled in me the Second Law of Thermodynamics far better than any professor in college ever did. Dare I say better than Lord Kelvin himself could explain. She did it by making me recognize we can never go back. And making me realize just how precious our time here on earth is.

It was incredibly insightful and at the same time, as my mother lay taking her last breaths on this earth, it was an earth-shattering lesson. I am way too old to believe in coincidences as what brought Karen and I together in 2011 was a true act of divine intervention. I am confident she was meant to write and post this blog, and I was meant to read it exactly at this moment in time.
